

**BOROUGH OF CRAFTON  
RESOLUTION NO. 2022-021**

**A RESOLUTION of the Borough of Crafton, Allegheny County, Pennsylvania, amending establishing a general schedule of fees, costs, charges, and expenses pursuant to Borough Ordinances and repealing any and all Resolutions inconsistent therewith.**

**WHEREAS**, Section 1202 of the Borough Code, 53 P.S. §46202, authorizes the Council of the Borough of Crafton (the “Borough”) to establish a schedule of fees as shall be necessary to cover the costs associated with Borough services and the collection of Borough accounts and expenditures; and

**WHEREAS**, the Council of the Borough desires to amend Resolution 2021-023 which established a general fee schedule for fire inspections; and

**NOW, THEREFORE**, the Council of the Borough of Crafton hereby resolves to amend Section 11 as follows:

**SECTION 1:**

Section 11 is hereby amended as follows:

**FIRE INSPECTION** – the following fees will be waived during the first year of the program; thereafter the following fees will be charged for the annual inspection. Reinspection will be half of the initial cost.

**A. Residential**

(1) R-1 (hotel/motel) 50 rooms or less	\$100.00
(2) R-1 (hotel/motel) 50 rooms or less	\$150.00
(3) R-2 (apartments) 3 to 8	\$100.00
(4) R-2 (apartments) 9 to 14	\$125.00
(5) R-2 (apartments) 15 to 20	\$150.00
(6) R-2 (apartments) 21 to 26	\$175.00
(7) R-2 (apartments) 27 units or more	\$200.00
(8) R-3 (single, duplex, townhouses)	Exempt
(9) R-3 (assisted living) 5 to 16 people	\$125.00

**B. Educational**

(1) Under 5,000 sq ft	\$100.00
(2) 5,001 to 10,000 sq ft	\$150.00
(3) Over 10,000 sq ft	\$200.00

**C. Mercantile, Business, Storage**

(1) Under 1,000 sq ft	\$100.00
(2) 1,001 to 5,000 sq ft	\$125.00

- (3) 5,001 to 10,000 sq ft \$150.00
- (4) Over 10,000 sq ft \$200.00

**D. Institutional**

- (1) Under 1,000 sq ft \$100.00
- (2) 1,001 to 5,000 sq ft \$125.00
- (3) 5,001 to 10,000 sq ft \$150.00
- (4) Over 10,000 sq ft \$200.00

**E. Assembly**

- (1) Up to 49 Persons \$100.00
- (2) 50 to 99 Persons \$125.00
- (3) 100 to 300 Persons \$175.00
- (4) Over 300 Persons \$200.00

**F. Factory**

- (1) Under 1,000 sq ft \$100.00
- (2) 1,001 to 5,000 sq ft \$125.00
- (3) 5,001 to 10,000 sq ft \$150.00
- (4) Over 10,000 sq ft \$200.00


**G. Daycare**


- (1) In Home \$60.00
- (2) Under 10 Clients \$100.00
- (3) Over 10 Clients \$125.00
