If the park shelters are not left in accordance with the Park Rules & Regulations a deposit refund will not be issued. Furthermore, the applicant is aware that there is **NO PARKING at the shelters or on any portion of the Borough laws**. **If you need assistance with drop off/pick up of handicapped persons please notify the Crafton Borough Administration in advance**. CANCELLATION POLICY: Cancellation of shelter rentals between Memorial Day and Labor Day will not be refunded their security deposit. A copy of the park rules has been provided.*
